#### Activities, events and programmes: April 2023 to March 2024

#### A SESSION ON CUSTOMER CENTRICITY

On January 19, 2024, a session on Customer Centricity was curated and hosted online by the Customer Centricity sub-council. The session was attended by 183 Tata employees and safety professionals from 18 Tata companies including Tata Steel group companies. This event was organised with a purpose to delve into the strategies implemented by some of the leading companies and the innovative techniques used by them, to ensure that the customer experience remains the central focus in their overall business approach.

R N Murthy, Chairperson, Customer Centricity sub-council and EIC of Tata Steel Tinplate Division, opened the proceedings focusing on Customer Centricity. He stressed on its vital role, increasing importance amid evolving customer preferences, technological advancements and global competition. He focused on embedding this ethos throughout the organisation, from strategy to operations, for enhanced loyalty, growth, and resilience in the market.

Sushant Dash, CEO of Tata Starbucks, emphasised elevating customer experiences

through innovative strategies in his talk 'Elevating experiences: The heart of Customer Centricity.' He highlighted the importance of leveraging digital advancements and customer insights for innovation. He detailed how Tata Starbucks personalises orders, fosters personal connections, and caters to local tastes with region-specific offerings, underlining the brand's deep commitment to Customer Centricity and personalisation to enhance loyalty and engagement.

Prashant Tandon, CEO and Co-Founder of Tata 1mg, shared insights into his company's journey, which has emerged as a patient-centric healthcare service provider. He detailed the approach for offering personalised healthcare management services. He elaborated on how Tata 1mg has successfully implemented an integrated omnichannel access system, ensuring that quality healthcare is more accessible to a wider range of customers.

Harit Nagpal, MD & CEO, Tata Play, discussed the company's focus on Customer Centricity, highlighting its success in creating sustainable differentiators for an enhanced customer experience. He emphasised Tata Play's efficient service connectivity and responsive



solutions as two key success factors in showcasing commitment to satisfaction. He explored the theme of 'Useful and inspiring innovation', detailing the transition from a traditional DTH service to a comprehensive OTT platform.

#### **SAFETY SYMPOSIUM**

The Safety, Health and Sustainability subcouncil conducted a safety symposium on December 22, 2023, at Beldih Club, Jamshedpur. The session was organised to foster cross-learning, encourage sharing of diverse industry-agnostic best practices and to provide a platform where organisations will work together and collaborate to further strengthen their strategies towards achieving zero harm. The symposium was attended by 85 Tata employees and safety professionals from 20 Tata companies including Tata Steel group companies.

Rajiv Mangal, Chairperson - Safety, Health & Sustainability sub-council TNF India - East & VP SH&S, Tata Steel, set the context of the symposium and shared key insights from the safety workshop led by the Group Chairperson. Neeraj Sinha, Chief - Safety, Tata Steel, addressed the participants on the topic 'The art of influencing safe behaviour at the shop floor'. He emphasised that creating a safety-conscious culture begins with clear communication of guidelines and expectations, ensuring that every worker understands the importance of adhering to safety protocols. Dr. O B Krishna, Distinguished Professor, IIT Kharagpur, addressed the participants on the topic 'An analytical approach to safety'. He highlighted the importance of leveraging data, statistics, and systematic evaluation to identify, assess, and mitigate risks in various operational contexts. Rama Shankar Pandey, CEO, Tata Green Batteries, through his session on 'Modern approaches towards road safety' shared an approach to combine advanced technology, behavioural insights, and comprehensive policies to address the complex challenges of ensuring safe transportation.

The panel discussion on 'Improving the risk perception of the workforce' was led by Vilas N Gaikwad, Chief - Safety, Tata Steel, and included panellists from Tata Power, Tata Motors, and erstwhile Tata Metaliks. The discussion focused on enhancing employees' awareness and understanding potential hazards in the workplace.

Vivek Harshanshul, Global HSSE&C Advisor, British Petroleum, emphasised aspects of contractor safety management and its criticality in maintaining a safe working environment in manufacturing or construction industries.

Jayanta Banerjee, CIO, Tata Steel, shared how digital prowess can be leveraged for proactive risk mitigation through 'Safety digital twin'. He deliberated on the role of advanced technologies to create a dynamic and datadriven representation of safety, promoting a holistic and proactive approach to safety management.

#### **ARTIFICIAL INTELLIGENCE EVENT**

The recent advances in artificial intelligence (AI) have made it a strategic imperative for businesses. AI is expected to have profound impact across diverse sectors such as manufacturing, retail, financial services and e-commerce to name a few. In light of this, TNF India - West held an event titled 'Preparing for the artificial intelligence transition' at Bombay House Auditorium, in Mumbai, on December 12, 2023, along with Aarthi Subramanian, Group Chief Digital Officer, and her team at Tata Sons.

The event witnessed one of the largest turnouts as it was attended by around 90 participants in-person and close to 1,000 virtually across Tata companies. In this session, the spotlight was on AI transition for enterprises, and the session began with a global perspective on 'State of Al' by guest speaker Aiham Al-Akhras from Gartner Research Board, Dubai. This was followed by sessions from four CEOs from diverse sectors, who shared their perspectives on this important transition. These four CEOs were T V Narendran (MD & CEO, Tata Steel), Rajiv Sabharwal (MD & CEO, Tata Capital), R Mukundan (MD & CEO, Tata Chemicals) and Girish Wagh (ED, Tata Motors). Next up was a session on 'Opportunities provided by GenAl' that can be harnessed', and an engrossing panel discussion with technology leaders from four Tata companies. The event concluded with a

demo of some GenAI projects showcased by select Tata companies.

The event envisaged to bring together diverse perspectives on this very topical subject that is now increasingly becoming the centre of focus in every company.

#### **SESSION ON 'PEOPLEHOOD'**

The Tata group currently comprises 9,35,000+ employees and operates in more than 100 locations across six continents. To catalyse this incredible mix of talent, the Group HR had planned to embed people vitality, sustainability & inclusion, at the very heart of the Group's business strategy. For this, TNF India - West organised an event titled 'Peoplehood' at Tata Management Training Centre (TMTC), Pune on April 5, 2023, in collaboration with Nupur Mallick, Group CHRO, Tata Sons, and her team.

The event was organised in a hybrid format (both, in-person and virtually), with 50+ Tata

employees attending in-person and 300+ virtual participation.

A panel discussion was held with four CEOs of Tata companies, namely Rajiv Sabharwal (MD & CEO, Tata Capital), Warren Harris (MD & CEO, Tata Technologies), Vinayak Pai (MD & CEO, Tata Projects) and Anand Sen (MD, Tata International), who brainstormed on four themes – purpose, wellbeing, growth and connectedness/belonging – and shared how they are driving these areas in their organisations with real life examples, insights and challenges. The panel discussion was moderated by Anand Shankar (Director, TMTC). This was followed by a TEDx style session where selected Blue Minters (people who have undergone the leadership flagship programme for early-career leaders across the Tata group) spoke on the theme of 'Sustainable workplaces'. The event ended with the launch of a digital art gallery with the theme of 'Inclusive mindsets'.

#### LAUNCH OF THE TATA INNOVATION EXCELLENCE FRAMEWORK

On September 27, 2023, the Tata Innovation Excellence Framework (TIEF) was formally

As a next step, TBExG and Group Innovation will encourage group companies to undergo self evaluation to identify strengths and opportunities for improvement and to organise Deep Dives using TIEF to introduce/ adapt global best practices in innovation management to achieve the desired impact on business.

#### SESSION ON ENTREPRENEURS' CONTRIBUTION TO COMMUNITIES

TNF India - North organised a session on 'Contribution of entrepreneurs in building communities' by Shantanu Naidu, General Manager at the office of Ratan Tata, Chairman Emeritus, Tata Sons, on July 26, 2023, at the Ambassador, New Delhi - IHCL SeleQtions. An engineer, a social entrepreneur and an author, Shantanu has been closely associated with Ratan Tata in driving various social endeavours. The event witnessed the participation of over 60 Tata employees from various companies.

The afternoon commenced with a welcome by Uma Gupta, Convener, TNF India - North, encapsulating the highlights of the forum, the purpose of its existing and past programmes. The opening address was then delivered by Rohit setting the context and introducing the guest speaker.

#### **BUSINESS EXCELLENCE TNF SESSION**

The Business Excellence TNF session was held on January 11, 2024, at Tata Motors Design Tech Centre (TMDTC), National Automotive Innovation Centre, in Coventry, UK, with 10 employees from 12 Tata companies - Jaguar Land Rover (JLR), Tata Business Excellence Group (TBExG), TMDTC, Tata Chemicals, Tata Steel Netherlands (TSN), Tata Steel UK (TSUK), TCS, Tata Limited, Tata Technologies (TTL) and Tata Consulting Engineers (TCE). Sanjeev Singh, Vice President & Head, TBExG, ioined the session from India. He shared an overview of the Business Excellence Convention that took place in December 2023. James Billingham, General Manager - Quality and Facilities, TMDTC, facilitated a site tour of TMDTC.

#### CORPORATE SOCIAL RESPONSIBILITY SESSION

The Corporate Social Responsibility (CSR) meeting, held on December 6, 2023 at the TCS London offices saw 21 employees from 10 Tata companies share updates on their CSR initiatives. TCS in Ireland emphasised on community engagement, education, and STEM programmes, collaborating with organisations like the Irish Red Cross. IHCL outlined ESG+ initiatives, promoting sustainability and women leadership development. Air India discussed its CSR strategy formulation, and Vistara presented CSR efforts in education, employability skills, and environmental sustainability. TTL, Tata Chemicals Europe, Tata Elxsi, and TSG, also shared their CSR activities. The meeting concluded with discussions on collaboration opportunities, shared resources, and future plans, highlighting the group's commitment to purpose-driven CSR efforts.

### TATA BRAND AND COMMUNICATORS' TNF MEETING

The Tata Brand and Communicators' meeting took place on November 22, 2023, at Tata Motors' European Design Tech Centre (TMEDTC), National Automotive Innovation Centre, Coventry, UK, with participation from 19 employees representing 11 Tata companies. Updates from various companies were shared, including TSUK's emphasis on transitioning to green steel production and the introduction of Agratas, the new battery business, which plans to address the global battery challenge. Tata Motors, TCPL, Tata Chemicals Europe, Air India, IHCL, Tata Elxsi, JLR, and TCL highlighted recent developments and initiatives. Notable achievements discussed included Tata Motors' leadership in the Indian EV market, the establishment of a pharmaceutical salt plant by Tata Chemicals Europe, and JLR's robust sales performance. The meeting also covered sponsorship details for India Inc/India Global Forum. The group expressed gratitude to Tim Jones, Executive Director, Tata Limited, for his contributions as he retires, extending best wishes for his future endeavours.

#### **HEADS OF COMPANIES MEETING**

The Tata Heads of Companies meeting, held at TTL in Leamington Spa, UK, on November 8, 2023, featured significant updates and insights by 20 employees from 10 Tata companies. Banmali Agrawala, President - Infrastructure, Defence & Aerospace, Tata Sons, spoke about the thriving Indian economy, emphasising a 15-20% growth in corporate performance and strong financial results across Tata businesses. Agratas presented a groundbreaking UK project in battery technologies. TSUK shared its ambitious decarbonisation journey, including a £1.25 billion investment proposal for state-of-the-art electric arc

furnace steelmaking at Port Talbot. Updates from TTL, TCL, JLR, TMETC, Tata Elxsi, and TCPL underscored growth, innovation, and collaborative efforts within the Tata network. Philip Collins, Founder, The Draft Writers, provided a compelling political insight, suggesting a strong likelihood of the Labour Party winning the next UK election. Tim discussed Tata's CBI membership and potential changes in sponsorship with the India Global Forum. The meeting concluded with plans for a Tata Innovation Showcase in 2024 and ongoing efforts to study the Group's economic impact in the UK.

### HEALTH, SAFETY & WELLBEING TNF IN JLR

The meeting on July 5, 2023, was hosted by Dr Steve Iley, Chief Medical Officer, JLR. There were 12 employees from 8 Tata companies. Topics included creating a culture of wellbeing, mindful leadership and encouraging engagement in safety leadership. Employees were also taken on a site tour of JLR's new health safety and wellbeing room.

#### ONLINE BUSINESS EXCELLENCE TNF SESSIONS

The Business Excellence TNF session was held on June 28, 2023, with 8 employees from 8 Tata companies – JLR, TBExG, TMDTC, Tata Chemicals, TSN, TCS, Tata Limited and TCE. On September 27, 2023, the second Business Excellence TNF session was organised with 6 employees from 6 Tata companies – JLR, TBExG, TMDTC, TSN, TSU and Tata Limited. Both sessions were hosted by Nigel Blenkinsop, Chair of the Business Excellence TNF and Executive Director, Company Quality and Customer Satisfaction, JLR. Topics included business updates from the companies, an update on capability building in Europe and the TBEM external assessment cycle, support requirements for business, data, digital and cyber excellence. The September session also talked about Data Excellence.

### TNF CHINA HR SESSION IN SHANGHAI

A TNF-HR session was conducted on November 17, 2023, and hosted by TCS China in Shanghai. This forum resumed after a threeyear hiatus with all the participants excited to finally meet again in person.

James Zhan, President, Tata Sons China, and Chairman, TNF China, and Suneet Puri, Country Head, TCS China, gave the welcome speech to the participants. HR best practices, data driven practices in recruitment and the TCS career management ecosystem were the highlights of the session. Other HR topics actively explored during the free discussion session were how to attract and retain talent post pandemic, how to cooperate with enterprises to reduce costs and increase efficiency from an HR perspective. These practical issues sparked an interest and HR employees shared respective practices to address these common challenges.

- On October 11, 2023, a public affairs virtual session was hosted with the Cohen Group and Tata companies about the political scenario in Washington and its impact on key policy and global trade issues. This meeting had 7 employees from 5 Tata companies including Tata Chemicals, TCPL, TCL, TCS and Tata Steel.
- On July 10, 2023, the group met with Jordan at the US Chamber of Commerce to discuss current data privacy policy issues. This meeting had 9 employees from 7 Tata companies including TCL, TCPL, Tata Chemicals, TCS, JLR and Tata Steel.
